

## **PRIVACY NOTICE**

Storm Capital Management AS recognizes the importance of processing data about you as an individual, such as your name, address or e-mail address (“Personal Data”). If you visit our webpage and/or communicate with us by receiving newsletters or in relation to recruitment, Storm Capital Management AS may collect and store Personal Data.

This Privacy Notice sets out how Storm Capital Management AS, with registration number 989 309 439, may use, process and store Personal Data, why this is done, and your rights regarding Personal Data that we hold.

In general, you can visit our website without revealing any Personal Data. We track the Internet address of individuals who visit our website and analyze this data for trends and statistics, but the tracked data does not include Personal Data. If you do not provide the information we request, you can still visit most of our website but you may be unable to access certain options and services.

### **1. Why we collect Personal Data, and what information we collect**

We collect, store and use Personal Data for different reasons, depending on who you are and how the Personal Data is collected. We collect information for some or all of the following reasons:

1. In order to provide information about our products and services, including sending newsletters, we use email addresses. Use of your email address is based on your consent.
2. In order to answer any inquiries, we collect your name, phone number, email address and any other personal information included in your inquiry. Our processing of Personal Data is based on a balancing of interests, and we have concluded that collection and use of this Personal Data is necessary to answer your questions.
3. For recruiting purposes, we may collect and store your CV, application, certificates and references. Use of this personal information is based on your consent.
4. To obtain information regarding your use of our website, we use cookies. Our processing of Personal Data is based on a balancing of interests, and we have concluded that collection and use of cookies is necessary to improve our website and to provide you with more tailored information when you return to the website. You may set your browser to tell you when you receive a cookie, and to refuse to receive it.

### **2. Sharing of Personal Data with third parties**

Storm Capital Management AS does not share Personal Data with third parties unless you have consented to allow us to do so, or for legal reasons. Storm Capital Management AS uses third party data processors to collect, store or in other ways process Personal Data on our behalf. We have entered into data processing agreements with all data processors we work with in order to ensure information security. Storm Capital Management AS does not transfer Personal Data to countries outside the EU/EEA.

### **3. Storing of Personal Data**

If you do not request us to stop using Personal Data, we retain Personal Data for as long as required by law. Personal Data that we have collected based on your consent is deleted if you withdraw your consent. Personal Data used to perform an agreement with you is deleted as soon as all obligations of the agreement is carried out.

## **4. Your rights**

In connection with our collection, storage and use of Personal Data, you have the right to request access, rectification or erasure. Further, you have the right to restrict our processing, to object to our processing and to port Personal Data elsewhere (data portability).

If you wish to exercise your rights, we will require that you confirm your identity by providing additional information. We do this to ensure that third parties are not given access to Personal Data.

## **5. Complaints**

If you believe that our collection, storage and use of Personal Data does not comply with our privacy notice or does not comply with privacy law, you may complain to your local data protection authority.

## **6. Changes to our Privacy Notice**

Storm Capital Management AS may change this notice from time to time in the future. Any such changes will be posted here and, where appropriate, notified to you in writing. We advise you to check back frequently to see any updates or changes.
